



The Alaska Department of Transportation and Public Facilities (DOT&PF), in cooperation with the Alaska Division of the Federal Highway Administration (FHWA), is proposing improvements on Seward Highway from Bird to Indian, MP 99 to MP 105, in the Municipality of Anchorage (Figure 1). This project will consider at least four alternatives for improving this portion of the road. The project is located in Sections 5, 6, 8, 9, 10 & 15, T10N, R01W, Seward Meridian (USGS Quadrangle Seward D-7 NW).

For purposes of the National Historic Preservation Act, we are initiating this consultation to assist us in identifying places that may be of traditional religious and cultural importance to your tribal organization. Please note that we are requesting information only on such places that you believe may be impacted by the proposed project so that we may try to avoid impacts. We would be pleased to discuss with you any confidential concerns you may identify and discuss project details.

Preliminary concepts under consideration by DOT&PF include: (1) a no build option; (2) rehabilitating the highway along its existing alignment; (3) a new alignment along the coastline that would separate the highway/rail facilities from Bird and/or Indian; and, (4) a new alignment that would route around Bird and/or Indian by moving the highway and railroad onto the coastline and tideflats of Turnagain Arm. Associated improvements to the build alternatives may





The Area of Potential Effect (APE) will extend 70 feet inland of the centerline and seaward to the coast except an inland area 0.4 miles north of MP 104 that extends approximately 400 feet inland from centerline (see Figure 2). An APE corridor of 140 feet will accommodate the route concepts currently under consideration and allows for five lanes plus a construction buffer, which is the widest that would be proposed. The inland portion of the APE is generally contained within the existing right-of-way for the Seward Highway, which varies from 150 feet to 200 feet; the seaward portion involves properties outside of the existing right-of way. Preliminary concept 4 above would move the highway and railroad onto the tideflats. For preliminary concepts 1-3, the tidal APE is the coastline, for concept 4, the APE would extend onto the mudflats. Although a cultural and historic resources survey would not be conducted on the tidal flats, these resources have been uncovered during the course of construction on other projects. This is illustrated on Figures 2 through 5.

An archeological and historic site survey was conducted along the project route in 2001 by Reger Archeological Consulting (Reger) for Cultural Resource Consultants (CRC). That report has not been processed by the State Historic Preservation Office and is being submitted along with this letter. Eleven known sites were described in the report as well as one newly located site along the project corridor, four of which are within the APE. These and other Alaska Heritage Resource Survey sites identified by CRC during their records review in early May 2006 are noted on Figures 2 through 5 and summarized in Table 1. The APE has been expanded since the Reger survey was conducted to accommodate potential alignment shifts and improvements along the entire corridor and now covers a broader area between the current highway and the coast. The DOT&PF will be assessing the previous survey work to determine any additional survey needs for this coming field season.

Judy Bittner contacted me to talk about an unrecorded historic site in the vicinity of MP 102 that was not discussed in the Seward Hwy MP 99-105 paving project no historic properties affected finding letter or the accompanying report. This was a follow-up to an email from Tracie Krauthoefer, OHA Review and Compliance Archaeologist, on August 9<sup>th</sup>, which indicated the need for additional information before determining a SHPO concurrence.

Judy indicated that this site was identified during a previous construction Seward Highway project about 4 or 5 years ago. Judy along with Stefanie Ludwig, OHA Review and Compliance Archaeologist, did a site visit with DOT&PF Resident Engineer. I said that it probably was Jeff Brown (who has since retired). At the time, Jerry Ruehle was the Central Region Environmental Manager (now at the H2H project office) and Susan Wick (also retired) was the Environmental Team Leader.

At OHA, the site's location is known only to Judy. Apparently the site was west and north of a hillside cut on the west side of the highway and was avoided during construction. Site features are two cabin depressions and foundations and associated can dump. Judy indicated that DOT&PF had committed to documenting the site, but there has been no submittal to her office.

I explained to Judy that our proposed action in the vicinity of MP 102 was limited to repaving the existing highway travel surface, with the exception of a culvert replacement at Ball Field Creek (MP 102.7). We were not proposing any additional work on the shoulders or highway embankment. The direct APE footprint in the MP 102 vicinity was confined to the existing travel surface and would not involve the unrecorded site. However, we would commit to a field review to locate and record the site.

On August 18<sup>th</sup>, I spoke with Jerry Ruehle and also with Susan Wick. The previous construction project was for Seward Highway MP 96-102 and each verified that Jeff Brown was the Resident Engineer. Both said that they did not have any additional information to provide although Susan believed that the site was north of Bird Creek. Construction had worked directly with Judy.

I also spoke with Jeff Brown on August 18<sup>th</sup>. Jeff said that he knows the site well and confirmed that it had been avoided during project construction. He agreed to a field visit with DOT&PF to relocate the site. I suggested this to happen during the week of August 23<sup>rd</sup> and that it would be coordinated with Central Region PD&E.

## **Summary of Changes in Project Scope**

The Seward Highway Milepost (MP) 99 to MP 105: Bird to Indian project was originally evaluated as an Environmental Assessment (EA) with 3 design alternatives: (1) No-Action Alternative; (2) resurfacing, restoration, and rehabilitation (3R) with Passing Lanes Alternative; and (3) Passing Lanes and Frontage Road Alternative. During the early planning process, rerouting the road into Turnagain Arm was discussed, but was ruled out due to cost and environmental concerns. The attached technical report may discuss multiple alternatives. However, the Categorical Exclusion (CE) document only relates to Alternative 2, 3R with Passing Lanes, which is the proposed design that is being carried forward. It is anticipated that there has been no change in the built and natural environment since the attached study was completed.
